

## ELECTRONIC CLIENT INVITATIONS

### STAND HOLDER EXHIBITOR

**ELECTRONIC CLIENT INVITATIONS:** Each exhibitor who holds a stand will have, included in the inscription fee, electronic exhibitor badges in proportion to the assigned area:

- N. 25 electronic invitations up to 40 sq.m. (value € 0,50 /one)
- N. 50 electronic invitations for over 40 sq.m. (value € 0,50 /one)

#### HOW IT WORKS:

1. The exhibition office will send exhibitors an email from [espositori.salonefranchising@fieramilano.it](mailto:espositori.salonefranchising@fieramilano.it) containing the link to access their personal page; once there, they can download their assigned invitation codes.
2. Exhibitors send an email with the assigned invitation codes to their clients (they can also add a personal message to send with the code).
3. The clients receive the emails from the exhibitors, access the page online, register and insert the assigned invitation code;
4. they will then receive an email with a PDF file to print and present at the entrance gates for direct access through the dedicated turnstiles
5. Each invitation code is valid for one daily entrance for one person.
6. Exhibitors will also be able to consult online statistics on the use of the invitation codes by their clients.

In addition to the electronic client invitations indicated above, each exhibitor stand holder may also order more electronic client invitations at a special price. **Please note: any other invitation or document issued by Exhibitors will not allow access to the Exhibition Area.**
